The Frequency Drive is used in conjunction with the Chore-Tronics[®] 2 or 3 Control to vary the speed of Chore-Times Vanguard[™] Plus, Turbo[®], and Endura[®] Fans that have been equipped with a 3 phase motor. Using this equipment for any other purpose or in a way not within the operating recommendations specified in this manual will void the warranty and may cause personal injury.

If such a defect is determined by Chore-Time to exist within the applicable period, Chore-Time will, at its option, (a) repair the Product or Component Part free of charge, F.O.B. the factory of manufacture or (b) replace the Product or Component Part free of charge, F.O.B. the factory of manufacture. This Warranty is not transferable, and applies only to the original purchaser of the Product.

CONDITIONS AND LIMITATIONS. The VFD enclosure must be mounted on a flat level surface no more than 20' [6.09m] from the Fan **as shown**.




Figure 1.Mounting




Figure 2.Wiring to CT2




Figure 3.Motor Wiring





Figure 4. Wiring with a Backup Relay
