DANGER: Electrical Hazard

Disconnect electrical power before inspecting or servicing equipment unless maintenance instructions specifically state otherwise. Ground all electrical equipment for safety. DANGER: Rotating Fan Blade


Keep hands away. Disconnect power before servicing. Fan may start automatically. Do not operate fan without screens in place. Disregard to these dangers may cause serious injury or death.

- Keep all safety signs and decals in good legible condition
- Replace damaged or missing decals.




Preparing the Fan Shroud

A) Using a 5/16" bit, drill two holes in each corner of the fan shroud if not already present. If holes are not present, check for small dimples in each corner in order to pinpoint hole locations. There may be two dimples in each corner approximately 2" from each other. If no dimples are found, use the Drill Template (**Item 1**).



- B) Replace the bolts on the top of the shroud orifice with two longer bolts (**Item 2**) included in the hardware package. If longer bolts are already installed, move on to the next step.
- C) Mount the four corner brackets (Item 3) using two bolts (54287) and two nuts (46764) per corner. The bolts should be sticking into the fan shroud. The nuts will need to be tightened from the inside.






Assembling the Cone

- A) Lay one panel flat with the tabs oriented to the left. Place a 2x4 or similar underneath the panel just left of the slots on the right side.
- B) Place tabs of a second panel into the slots of the first and ensure they 'pop' together fully.
- C) Lay this second panel flat then move the 2x4 over just to the left of the slots again.
- D) Repeat these steps until all four panels are locked together.
- E) Lift the panels up and curl them into a ring so that the larger diameter is upwards.
- F) Snap the tabs of the first panel into the slots of the fourth panel.


a. Ensure all tabs are toward inside of cone!

- G) Fasten all four bottom holes with (54287) bolts and (46764) nuts making sure the bolt heads are on the inside of the cone and the threads are sticking to the outside.
- H) Place the grill (56230) inside the cone and secure with eight more (46764) nuts and (54287) bolts. Make sure seven of these bolts are oriented with the head inside the cone and threads outside. The eighth bolt will be the bottom of the cone. It must be attached with threads inside the cone and head outside the cone. It should not be on any of the four seams between panels.



Mounting the Cone


A) Pick up the assembled cone and hang it on the top two bolts. Make sure the four seams are oriented towards the four corners of the fan shroud. The one bolt with threads toward the inside of the cone should be at the bottom of the cone.




D) Secure the bottom two corner brackets with two additional (46764) nuts.

Attaching the Cable Assembly

A) Secure the door stop cable assembly to the bottom bolt of the cone using two washers (ST99070) and one nut (46764).

If such a defect is determined by Chore-Time to exist within the applicable period, Chore-Time will, at its option, (a) repair the Product or Component Part free of charge, F.O.B. the factory of manufacture or (b) replace the Product or Component Part free of charge, F.O.B. the factory of manufacture. This Warranty is not transferable, and applies only to the original purchaser of the Product.
